2. Proposal may be submitted for a dollar amount earmarked for project collaborative funds.
3. Proposals containing personnel, personnel benefits, general operating expense or direct or indirect administrative costs are respectfully denied.
4. Proposal application deadline October 31 of each year, applications received after this deadline will be rolled over to the next year.
